- Submittal letter on Agency letterhead with agency determination (AFNSI, FONSI, or EISPN – see, Sections 11-200-11.1, or 11-200-11.2, HAR) and request for publication
- One hardcopy of the publication form
- One hardcopy of the EA
- On compact disc - one copy of the EA (as pdf) and the publication form in MS Word (or rich text file)

Environmental Impact Statements:

- Submittal letter to OEQC with request for publication (for an agency action, submit on Agency letterhead with request for publication with copy to accepting authority; for an Applicant action, ensure that the approving agency simultaneously receives the submittal to OEQC).
- One hardcopy of the publication form
- One hardcopy of the Distribution list for verification by OEQC prior to distribution.
- One hardcopy of the EIS
- On compact disc containing one copy of the EIS in PDF and the publication form in MS Word (or rich text file).

Other documents: Section 11-200-27, HAR determination that a supplemental statement is not needed; notices of withdrawals (specify what is being withdrawn); other documents requiring publication in the periodic bulletin (i.e., Incidental Take Permits, Habitat Conservation Plans, etc.).
